I received an email from one of your supporters regarding a critical story written about you and your organization, "600 Million Stray Dogs Need You." She requested (I am including her and her email in this letter) that I contact you about your organization. She believes you will respond, so I do hope and expect to hear from you soon, preferably by the end of the week.


I have recently received a number of solicitations from you so I was already interested in finding out what, if any, progress you had made on developing a drug that you claim will "...end the killing of homeless dogs and cats by ending the overpopulation problem by developing Spay and Neuter Cookies . . . food that will only need to be eaten one time to spay a stray."

As it happens, I am not the only person who was concerned about your claims. On your Facebook page [https://www.facebook.com/600milliondogs] posts were made requesting an honest update about the "cookies."

A similar post and response was made on March 24, 2017:



You state you started your organization in 2009 and are "a third of the way through clinical trials."

Question #1: Performing clinical trials on animals requires documentation. Have you submitted any documents to the FDA or any other governing body regarding any clinical trials?

Question #2: As it has taken eight years to get just a third of the way, can the public expect that it will take another sixteen years before the cookies are ready? In your February 8 Facebook post you solicit money in order to "expedite" the process, however, even if you are able to do that, would we still be talking about another 13 or so more years before any product becomes available for use?

In your 2011 IRS 990 tax form, it states that you gave \$40,000 to a single person somewhere in Central America for "formula clinical trials." In your 2012 990 form, you again sent \$20,000 to "Central America" though this time there were four people involved:

Question #3: Who exactly was the individual you sent \$40,000 in 2011 and what exactly did they do with money you sent to them?

Question #4: Who were the four people you sent \$20,000 in 2012 and what did they do with the money?

Although you sent \$60,000 to Central America in 2011 and 2012, there were no further references regarding this in your 2013- 2015 990 forms.

Question #5: If you were doing actual clinical trials in Central America, why did you stop and what happened to any/all the data collected?

Question #6: If you are still doing clinical trials, where did they move to after 2012?

• Please note that we were not able to find any IRS 990 form prior to 2011, so consider this an official request for those documents.

Furthermore, please send us Attachment #4 from your 2013 990, Attachment #4 from your 2014 990 and attachment #1 from your 2015 990 which describes your program expenses and accomplishments to which you spent \$61,200, \$212,000 and \$270,250 respectively.

In your 2014 IRS 990, it states that you spent \$48,931 on "VOLUNTEERS RECRUITING," while in 2015 you spent \$55,784 on "VOLUNTEERS RECRUITING MEMBERS."

Question #7: Can you explain what exactly these expenses were for and why it would cost so much for "volunteers" to either be recruited or for them to recruit "members?" Please provide documents.

In a Facebook post published on February 15, 2017, you state that you do not "...disclose much about our processes..." because you fear a pharmaceutical company will "...patent a formula based on any information we disclose..."

We are not asking for any specific information on the drug itself, therefore there is clearly no concern that information you provide will result in any patent theft. This then should not be an excuse for you to conceal the information we have reasonably requested.

It is our hope that the money you are soliciting and spending is being used for legitimate purposes, however, you do owe those that you have taken money from to provide honest and forthcoming answers not like the evasive ones posted on Facebook.

I look forward to hearing from you and continuing this discussion.
