INFORMATION

Martin Beltz, Assistant State's Attorney, informs the Court that the above defendant, committed the following offenses within Perry County, Illinois, on or about September 23, 2018, to wit:

COUNT I- ANIMAL TORTURE

In that said defendant without legal justification knowingly or intentionally tortured an animal, an approximately 1-2 year old female deer, in that he kicked or stomped said animal multiple times with his foot, inflicting upon the animal or subjecting the animal to extreme physical pain, motivated by an intent to increase or prolong the pain, suffering, or agony of the animal.

Class 3 Felony

In Violation of 510 ILCS 70/3.03 (a)

COUNT II- CRUEL TREATMENT OF AN ANIMAL

In that said defendant intentionally beat, tormented, cruelly treated or otherwise abused an animal, an approximately 1-2 year old female mixed deer, in that he kicked or stomped said multiple times in the head and/or body with his foot.

Class A Misdemeanor


In Violation of 510 ILCS 70/3.01
